226/19 MATTERS ARISING ON THE AGENDA

(1) **Highway Matters**

LHI 2019/20 – information as been received about the 40mph buffer zones for east and west approaches to the village. Gates and signs will be retained at the end of the 30 mph zones and new 40 mph signs put on the other side in place of the national speed signs. New 40 mph roundels will be placed along Decoy Road near Turnover Farm and along Gorefield Road after the Fendyke Lane junction. Road markings are also to be redone along Wolf Lane at entrance to 30 mph zone. Everyone was in agreement with these proposals. Clerk to confirm acceptance.

(2) Streetlights

Councillor King has received further information about streetlights FPC3 and FPC4 in Cattle Dyke. They were replaced in 2009 which has been confirmed by Cambs CC including the EDF services. For some reason the electricity service has been removed. The new contractor has obtained a quote of £1081to reinstate the service. It was agreed that there was no other option than to agree to the payment of this amount.

Streetlight opposite Oxfield Drive was originally a pole bracket and this has now been replaced with a column which was then hit by a vehicle and it was thought that the developers again replaced it. It now appears that this light does not form part of the Section 38 agreement. The Parish is invited to accept this streetlight column in place of the original pole bracket and then it will be added to the inventory and then a request will put through to the contactors for the repair. Councillor King will make further enquiries about this light before any agreement is made.

(3) Play Equipment

Nothing has been heard recently clerk will once again chase the contactors and ask for a quote for any work that is needed.

(4) Extension to Community Hall

(5) Web Site

Web site is now up and running. Councillors Humphrey and Thatcher and the clerk will attend training on Friday.
